5. SCC Training
 - All members of SCC are encouraged to attend the SCC training, held several times over the next two months. All SCC members indicated they would attend either the 9-21-17 or 10-4-17 training
6. Canyons District Bond (Handout 1)
 - Highlights of the Bond discussed: new buildings on a tax-neutral position
 - i. Committee members discussed known drawbacks, including the proposed Addition to Corner Canyon High School
 - District employees are not allowed to endorse a position on voting
 - SCC cannot endorse a position on voting
 - District officials are concerned of the viability of the vote and encourage community members to voice their support of the Bond.
 - i. Organizations not affiliated with the school can endorse the Bond, i.e. Neighborhood social media groups, & PTA
7. CSIP Character Education
 - BLT has recommended the suspension of the 8-keys program due to unforeseen cost. BLT will continue to research viable options to implement in the 2017-2018 school year
 - i. Points of discussion
 1. Jessica Dalton: 8 Keys was an important way to honor the memory of Gretchen Murray
 2. Melinda Morgan: Pointed out that the school could still pursue fundraising efforts through the community and PTA support
 3. Leslie Jewkes: BLT will keep 8-keys as an option, but will investigate other options

9. Volunteers and Visitors
- District has asked that schools closely track visitors and volunteers
 - Teachers list expected volunteers on a shared calendar
 - Teachers list expected guests on a shared calendar
 - Front office staff do not allow unexpected guests to be in the school during school hours
 - Leslie Jewkes asks for SCC approval of the new Volunteer and Visitor protocol
 - i. 8 Yay, 0 Nay
10. Emergency Procedure (Handout 8)
- Leslie Jewkes asks SCC council members to review the evacuation and emergency procedures and to return with feedback
 - Points of discussion
 - i. SCC role in family reunifications: SCC Members will help with crowd control after a lockdown has occurred. SCC members are advised to direct disruptive or argumentative individuals to the police.
 - ii. Chain of communication: SCC and PTA members are to report to the school once they receive the SKYWARD notification that the school is on lockdown. Phone calls to the school are diverted and Leslie Jewkes will only communicate with district officials and the police during the emergency
 - iii. A script will be developed for SCC and PTA parents to help with crowd control
11. Cleats
- Cleats damage the hallway. Students have been asked not to wear them at school
12. Playworks
- New Playworks coach is running into student engagement problems at recess
 - i. Trading cards will be banned from school grounds
 - ii. Kids reading at recess: Committee recommends using a “Reading at Recess” pass as part of Teacher Prize Boxes to limit the number of times an individual student is reading at recess.
13. Cell Tower Funds
- \$2000.00 is available to put in the Principal Fund
 - Leslie Jewkes: Motion to allocate all \$2000.00 into Principal Fund
