- 7. Character Education report from BLT
  - a. Different grade levels contributing to make proposed programs appropriate for each grade level
  - b. December BLT meeting will formulate two wish lists
    - i. First list will order proposed programs by practicality of implementation
    - ii. Second list will order proposed programs by desires of BLT, regardless of cost
    - iii. Melinda Morgan voiced importance of 8 keys of excellence and was supported by most of the SCC. Message was sent back to the BLT that there are parents in the community that will support a fundraiser to purchase the program that will best benefit Peruvian Park Students.
    - iv. Leslie Jewkes points out that SCC cannot sponsor a fundraiser and SCC funds used for purchase of the Character development program would funnel funds away from technology purchase. BLT and SCC agree that technology purchases cannot be sacrificed at this time.
